### **YWCA Saskatoon – WestJet Raffle Official Rules:**

By participating, entrants agree to be bound by these Official Rules and by the decisions of YWCA Saskatoon, which shall be binding and final as to all matters related to the Raffle. The Raffle is operated under Provincial Lottery License No. RR24-0133 and is subject to all applicable federal, provincial and local laws.

All net proceeds of the Raffle will benefit YWCA Saskatoon, (hereafter known as “Sponsor”) and the programs and services that the Sponsor supports.

#### **1. Eligibility:**

Entrants must be 19 years of age or older.

Tickets may only be purchased or sold in Saskatchewan.

Ticket purchasers must use a valid email address to purchase tickets and claim prizes.

Executive, staff, board members, directors, family and volunteers of the YWCA Saskatoon and all contributing partner companies are eligible to purchase tickets for the WestJet Gift of Flight and Uniglobe Carefree Travel Gift Card.

##### A) WestJet Gift of Flight:

1) This voucher is valid for one (1) roundtrip flight for two (2) guests to any regularly scheduled and marketed WestJet destination. Gift of flight vouchers are not valid for redemption on WestJet Vacations' or Sunwing Vacations' packages, flights operated by Sunwing Airlines, charters, codeshare, or interline flights.

2) This voucher is limited and subject to promotional space availability of eligible fare options and flight schedule. Not all flights have promotional space.

10) The individual booking the flights must be over the age of majority in their province.

In the event that it has been sold, the voucher will become void, and any flight bookings made with it will be cancelled immediately without notice or reimbursement.
